FVAP rounds out 2015 with major wins

FVAP is celebrating a very successful 2015, including a year-end total of 9 new published cases and three new legal victories in December.

Our three successful cases in December addressed a wide range of problems facing domestic abuse survivors. In the first two cases (*McIntyre v. Minkey*, Dec. 15; and *Rodriguez v. Menjivar*, Dec. 16), we **secured our clients' rights to restraining orders to keep them safe**, overturning the trial court decisions that denied them protection, in part because the abuse they feared was not physical. *McIntyre v. Minkey* also held that a warning from a trial court judge is not a suitable substitute for a restraining order, and *Rodriguez v. Menjivar* held that denying a restraining order based on the length of time that has passed since abuse occurred is not, and has never been, acceptable. The third case, *Noergaard v. Noergaard* (Dec. 16), was a contentious case involving international child abduction from Denmark and allegations of domestic violence. The case says that in instances involving international child abduction by one parent, if a child faces "grave risk" of harm if returned to the other parent in the home country, the trial court must consider evidence of abuse when making its decision. Also, if there is evidence that the status quo in the home country was abusive, speedy return to that country should not be the goal of California courts. FVAP filed a friend-of-the-court brief and presented oral argument, and we're thrilled with this result. In addition to these important legal victories, FVAP's 2015 cases will help thousands of domestic abuse survivors throughout California by setting important new legal precedent that prioritizes the safety of survivors and their children. We have already begun training members of the legal community on this new case law, including six California judges.

We are very optimistic about what 2016 will bring!

Leading the campaign for verbatim court records in CA



On Feb. 8, FVAP's Director of Programs Jennafer Dorfman Wagner testified before the **Commission on the Future of California's Court System** about the importance of keeping verbatim records of trial court proceedings, and about the serious due-process and access-to-justice problems that arise for CA domestic abuse survivors because more than half of California's 58 counties do not provide trial court reporters.

Without court reporters, there is usually no record at all of court proceedings. Without a record, it is often impossible for low-income domestic violence survivors to appeal court decisions that leave them and their children in danger of abuse.

This issue is crucial not only to our clients, but also to FVAP's ability to continue building a body of case law that ensures California law puts the safety of abuse survivors and their children first.

In addition to testifying, FVAP submitted a letter to the Commission on behalf of 20 other local, state, and national legal aid and domestic violence organizations. To read the letter and learn more about this problem, click here.

Court record issue heads to the CA Supreme Court

FVAP also played a role in the CA Supreme Court's decision to hear *Jameson v. Desta*, a case that demonstrates the need for verbatim court records for low-income people. We submitted a friend-of-the-court letter urging the Supreme Court to take this case and stressing its importance for domestic violence survivors and children throughout California. The CA Supreme Court receives thousands of requests for review every year and accepts fewer than 5% of them, so this is a significant victory.

Thanks to the many organizations who co-signed our letter to the Supreme Court, including domestic violence and legal aid organizations across California.
