Our September Legal Victory

We are thrilled to announce our latest legal victory!

FVAP helped another domestic violence survivor renew a restraining order against her abuser by successfully appealing a trial court decision that originally denied her renewal. (Cueto v Dozier)

With co-counsel **Cooley LLP**, FVAP put forward that the trial court abused its discretion in SUCCESS!

FVAP lands another legal victory for domestic violence survivors in California

denying a restraining order renewal based on its finding that the survivor had no reasonable apprehension for further abuse. This decision was unfair because the original restraining order was precipitated by a "violent incident," and because no circumstances had changed to diminish the opportunity or likelihood of further abuse. Thanks to **Domestic Violence Collaborative of San Mateo County** for referring this case to us!

Another notable accomplishment this month is a first for FVAP: On Sept. 29, the California Court of Appeal directly quoted FVAP's amicus curiae brief, expressing agreement with our argument that the trial court was wrong to say that, because the domestic violence survivor had not attended therapy, her fear of abuse must not be genuine or reasonable. The Court of Appeal credits FVAP by name while stating that, in order to renew a restraining order, a DV survivor need not go to therapy in order to prove that she is indeed afraid of future abuse.
