## What's New with Housing for Survivors



FVAP's Housing & Employment Justice Attorney, [Taylor Campion](#), has been busy doing trainings and creating a body of resources that focus on obtaining and maintaining safe housing as a survivor of domestic violence.

The [Helping Survivors Obtain Housing Toolkit](#) includes several resources to help survivors clean up their credit and address the common forms of discrimination that survivors face when applying for housing.

### Highlights in Statewide Education

- The [Housing & Employment Justice Program](#) also now creates a monthly legal tip that is emailed to domestic violence organizations in California to help keep advocates informed of legal rights survivors have when it comes to their housing and employment. For example, in certain circumstances, federal law makes it illegal for housing providers, like landlords and property managers, to refuse to rent to survivors of domestic violence, or to charge them higher rents or security deposits.

- On Tuesday, April 16, [Taylor](#) participated as a panel member for the “Nuisance Ordinances and Crime-Free Housing: How These Policies Threaten Housing Security” training at the [Housing California conference in Sacramento](#). The panel discussed how nuisance ordinances put in place to mitigate excessive noise and criminal activity can jeopardize housing security for domestic violence survivors, people with disabilities, and others.

We are thrilled the [Housing & Employment Justice Program](#), which was just launched in 2018, has grown so much in a short time. We look forward to expanding the body of resources available and continuing to educate and inform survivors and the field on the very important issue of survivors obtaining and maintaining safe housing—and to bringing our appellate strategy to help shape the law.

## Legal Victory: FVAP Supports Latham & Watkins in Restraining Order Win



[FVAP](#) was honored to provide real-time legal assistance to the pro bono legal team at **Latham & Watkins**, who successfully appealed the denial of their client's request for a domestic violence restraining order. In an unpublished opinion, the Court of Appeal decided Latham's client should have been granted the restraining order she requested because she submitted a written declaration of acts that are abuse under the Domestic Violence Prevention Act, and the opposing party did not contradict or impeach her declaration. [FVAP](#) provided assistance with the case strategy and the legal briefs and organized two moot court sessions to prepare Latham for oral argument. Many thanks to [FVAP](#) pro bono volunteers **MC Sungaila, Marco Pulido, David Farkas, Jeanette Barzelay, and Erin Gilmore** for helping prepare the victorious legal team in moot courts, and to **Latham & Watkins** for doing this important work!
