Legal Victory for Survivors Seeking a Long-Term Domestic Violence Restraining Order



FVAP represented a survivor in a recently published case, [N.T. v H.T. \(2019\) 34 Cal.App.5th 595](#), in which the Court of Appeal overturned the trial court's denial of a domestic violence restraining order request. In doing so, the Court of Appeal ruled that a violation of a temporary restraining order constitutes abuse under Family Code section 6203(a)(4). The Court of Appeal also held that the conduct underlying the violations constituted abuse under Family Code section 6320.

A Step in the Right Direction for Limited-English-Proficient Survivors



In 2014, long before we met our client, she went to trial court hoping to resolve a custody matter, but the hearing was actually for a domestic violence restraining order, which she needed but did not know that she was supposed to discuss at that time. Our client didn't know this because she is limited-English-proficient. Even so, she was not granted an interpreter. Because of this lack of support, it has taken 5 years for her to get a proper domestic violence restraining order hearing, which will now be held in the trial court.

Although an unpublished opinion, we are happy to share that [FVAP](#) was able to represent this survivor and help her appeal a ruling that would have kept her from presenting the details of her abuse in court to get a fair chance at protection. [FVAP](#) also helped in securing a trial court attorney for this survivor.

Legal Victory for Family and Household Members Who May Experience Abuse



In the recent published opinion, [Tanguilig v. Valdez \(2019\) ____ Cal.App. ____](#), the **Court of Appeal for the first time established what is “good cause”** for adding family and household members to a protective order stating that this “includes reasons that are fair, honest, in good faith, not trivial, arbitrary, capricious, or pretextual, and reasonably related to legitimate needs, goals, and purposes.”

Although this case involved an elder abuse restraining order, this ruling can still be helpful to survivors who want to protect their family and household members as part of their restraining order. Because the laws are very similar, this makes it appropriate to ask a judge to look to an elder abuse case when making a decision about a domestic violence restraining order.

FVAP Sponsored Bill Moves to Senate





We're happy to share that **Assembly Bill 925**, a bill [FVAP](#) is sponsoring, has moved to the Senate. This bill addresses an issue concerning minors' confidential information in protective orders. Currently, if a minor, or their parent or guardian, want to keep information about the minor contained in a restraining order matter confidential, the confidential information can only legally be disclosed to the abuser and law enforcement. If the minor or their legal guardian share the confidential information with other individuals, then the court must impose a \$1,000 sanction against the minor or the legal guardian. This is the case even if the other individuals need the information to keep the minor safe, for example, child-care providers, schools, and medical professionals. If the Senate agrees to pass this bill, minors and their parents would no longer be liable for voluntarily disclosing this information to people who need to know it to keep the minor safe from domestic violence.
