FVAP Gets Ready for Oral Argument

On May 17, FVAP will present oral argument at the First District Court of Appeal (San Francisco).

FVAP and co-counsel Bay Area Legal Aid and Folger Levin represent an abuse survivor who is appealing the court's denial of her requests to renew a restraining order against her abuser, and to add her children to the restraining order as protected parties.

To renew a restraining order, a victim of abuse must show that she has a reasonable fear of future abuse. Despite finding that the abuser violated the original restraining order by repeatedly directing harassing communications to our client, the trial court denied the renewal, stating that the violations did not involve acts or threats of violence. But California law specifically defines abuse to include non-violent harassing and intentionally annoying communications.

Our appeal also challenges the trial court's finding that alleged child abuse cannot be a basis for a mother's "fear of future abuse," and challenges the trial court's failure to consider that alleged abuse in relation to the request to add the children as protected parties to the restraining order.

This case demonstrates the importance of taking alleged child abuse into account when considering whether a child's parent should be allowed the protection of a restraining order against the alleged abuser. Check our website for updates on this case.

59 Ways to End Domestic Violence Homicide



In a recent Huffington Post article, domestic violence survivors and advocates from across the country wrote in with 59 ideas for specific, practical steps we can take to end our nation's epidemic of domestic-violence-related homicides.

Three U.S. women are killed on average every day in domestic-violence related homicides, and experts agree that many of these killings are preventable.

At FVAP, we are already working hard on many of the ideas on this list:

- "Judges: When a victim is asking for a permanent restraining order, grant it!" Kate Ranta, domestic violence and gun violence survivor
- "In my first domestic violence case as a young lawyer, a client was shot by her estranged husband when he arrived for visitation exchange. Courts must stop forcing victims to share custody, legal or physical, with an abuser (who will doubtless use the child to punish her for leaving, and maintain power and control over her), and must not require the victim to be alone with the abuser for visitation exchange." — Kim Gandy, CEO of the National Network To End Domestic Violence
- "Do not force victims to be in the same courtroom as abusers. Allow for testimony to be taken separately and safely." — Kate Ranta, domestic violence and gun violence survivor

If we continue to push our courts to better protect survivors, we believe real, long-lasting change is possible. FVAP's goal is to reform the California court system so that every abuse survivor who passes through it is fully protected – and not in danger of ongoing or heightened abuse.

FVAP Launches Dependency Law Advisory Panel

FVAP is pleased to announce that we have assembled a panel of Dependency Law Advisors to advise us on juvenile dependency issues.

The Honorable Leonard Edwards (Ret.); Wendy Seiden, Associate Clinical Professor at the Bette & Wylie Aitkin Family Protection Clinic at Chapman University; and Cristina Gabrielidis, attorney for the abuse survivor in In re M.W., will bring their dependency law expertise to FVAP to ensure the perspectives of children and families navigating the dependency court system are heard.

In California's dependency court system, domestic violence restraining orders between juveniles are heard, and custody and foster care decisions are made in families living with abuse. We have assembled these expert advisers to enable FVAP to help more people navigating this system.
