

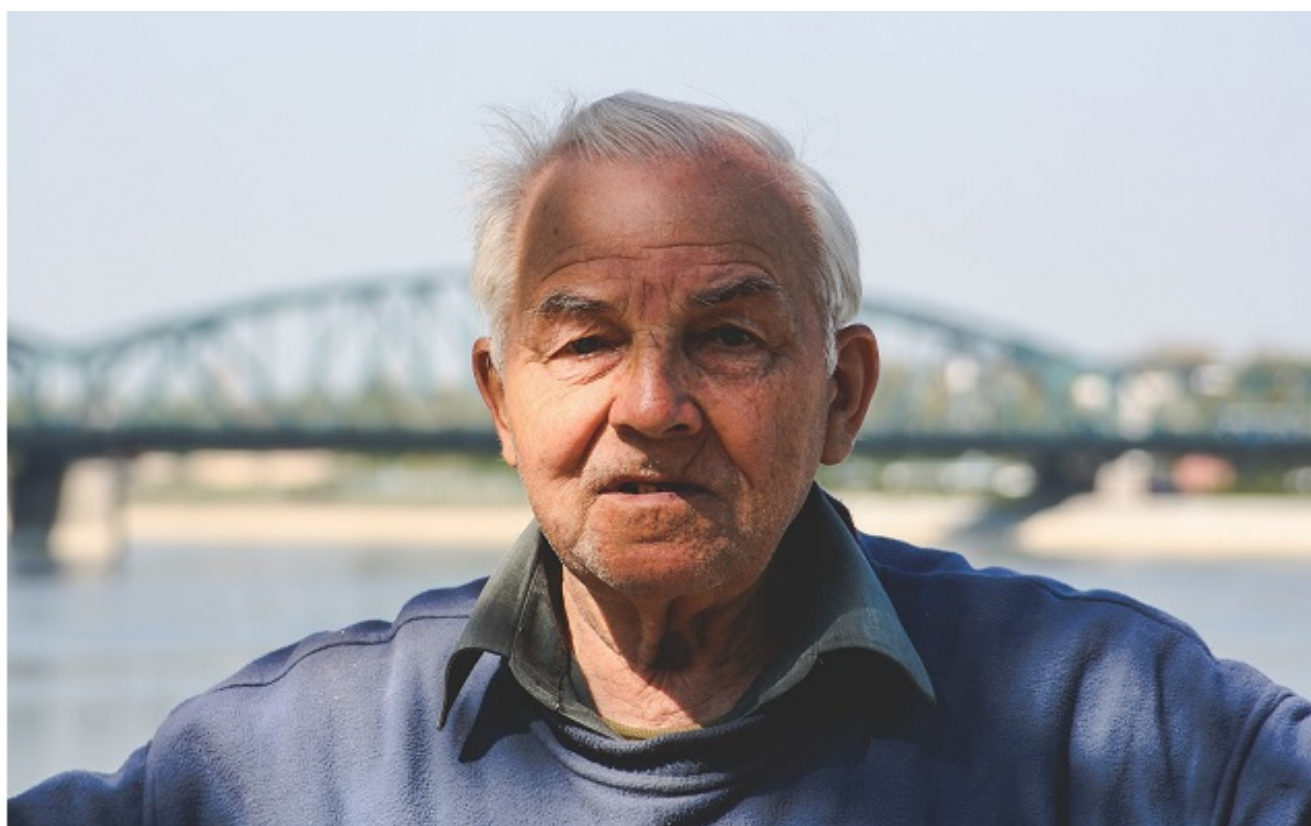

## FVAP Legal Victory in Elder Abuse Case



FVAP took on an **elder abuse case** in which our client had obtained a restraining order protecting him from his former intimate partner who had become his live-in caretaker before beginning to physically, economically, and psychologically abuse him. The abuser sought to **appeal the restraining order** but then asked to postpone the appeal, which would have caused more trauma for our client. We worked with [California Indian Legal Services](#) to oppose this and were successful.

As of this month, the **abuser's appeal has been dismissed** for her failing to comply with court-ordered deadlines. We are thankful that our client is still protected by his restraining order and can begin to move forward.

## Immigration Toolkit Released



[FVAP](#) just released our **Immigration Toolkit**. This toolkit addresses the unique challenges immigrant survivors of domestic violence face when seeking protection from their abusive partners in California family, juvenile, and probate courts. The toolkit includes helpful resources including:

- A fact sheet that briefly explains three key California cases that address issues immigrant survivors of domestic abuse may frequently experience
- A tip sheet explaining California Evidence Code section 351.3, which protects a person’s immigration status from being asked about or discussed (“disclosed”) during court proceedings
- A model Memorandum of Points & Authorities (legal brief) in Support of a Request to Enforce the I-864 Immigration Form
