FVAP Article on Secretly Recorded Evidence Gets Published



The [California Association of Certified Family Law Specialists](#) published an article written by FVAP Senior Managing Attorney, [Shuray Ghorishi](#), and the Honorable Judge Mark Juhas in their journal. The article, [California Penal Code 632: The Dilemma of Secretly Recorded Evidence in Family Law and Abuse Cases](#), explores the **nuances of secretly recorded communications** in family court cases. There are circumstances in which a secretly recorded conversation will not be admissible in court, however, under some statutes there are certain kinds of crimes where an exception may be made, and domestic violence is one of those crimes.

Unfortunately, it is common for aspects of family law and abuse cases in which there has been a secret recording to still result in the recording being inadmissible in court. This article provides **key information** that aids attorneys so that they can better advocate for their survivor clients on this issue.
