FVAP Team Heads to Annual Domestic Violence Conference



Every year, the FVAP team travels to the California Partnership to End Domestic Violence's annual Shifting the Lens conference to inform advocates in the domestic violence field about our work and how we are helping survivors. And in tandem with sharing information about our work with fellow advocates, we also attend Shifting the Lens to listen and learn so we can ensure that we are doing the very best for survivors and their kids.

This year, FVAP Director of Programs Jennafer Dorfman Wagner presented "Confidentiality and Mandated Reporting: A Comprehensive Tool-Kit for Domestic Violence Advocates and Agencies" at the conference, along with the Confidentiality Institute. This training and toolkit followed FVAP's all-day training series on confidentiality and mandated reporting that we presented in 5 locations throughout California in 2018.

Covering the State: Domestic Violence Best Practices, Housing & Employment, and More



FVAP is busy traveling the state to train people in the field about important domestic violence legal issues. Here are some of our **recent trainings**:

February 22: "Recent Developments in California Domestic Violence Law Cases and Statutes and the Psychology Behind Them," was given in **Costa Mesa, CA** by FVAP Legal Director Nancy K.D. Lemon with Alameda County Superior Court Judge Tara Flanagan and FVAP Advisory Board member Dr. Mindy Mechanic, Professor of Psychology at California State University, Fullerton.

February 28: "Protective Orders and the Advocate's Role" was presented in **Sacramento**, **CA** by FVAP attorney Cassandra Allison to members of the California Partnership to End Domestic Violence's North Region.

February 28: "Housing & Employment Rights of Domestic Violence Survivors" was presented in **Sacramento, CA** by FVAP's Housing & Employment Justice Attorney, Taylor Campion.

March 20: "Using the Courts to Advocate for Survivors of Domestic Violence" was presented by FVAP Legal Director Nancy K.D. Lemon at the 19th Annual International Family Justice Center Conference in **San Diego, CA**. The training focused on best practices for civil attorneys in representing and advocating for domestic violence survivors.

Upcoming trainings:

April 16: FVAP's Housing & Employment Justice Attorney, Taylor Campion, will be part of the "Nuisance Ordinances and Crime-Free Housing: How These Policies Threaten Housing Security" panel at the Housing California conference in **Sacramento**, **CA**. The panel will discuss how nuisance ordinances put in place to mitigate excessive noise and criminal activity can jeopardize housing security for domestic violence survivors, people with disabilities, and others.

April 24: "Orientation to Domestic Violence" will be presented by FVAP Legal Director Nancy K.D. Lemon at Practicing Law Institute in **San Francisco**, **CA**. This session provides an overview of what domestic violence is, types of abuse, the cycle of violence, why individuals stay in abusive relationships, cultural contexts of domestic violence, and special considerations relating to same-sex domestic violence relationships.

What the talent has been up to:

- On January 13, FVAP supporter and Yoga Instructor at CorePower Yoga, Bishwanie Sookhai, held her Yoga Sculpt class with all proceeds directed to FVAP, bringing in \$395 for survivors.
- On February 21 & 22, the Womxn of Color Collective at Berkeley Law performed a version of the popular stage show Vagina Monologues called "Our Monologues." They brought in \$2,720 in ticket sales, all designated to FVAP.
- On March 21, the MauxFaux band (of Faraday Future, Praedicat, Inc., and Strumwasser & Woocher LLP), played at the annual Law Rocks fundraiser in Los Angeles in support of FVAP, raising \$6,113 for survivors.
