FVAP client secures permanent domestic violence restraining order after appellate victory



Last December, [FVAP won an appellate victory](#) when the Court of Appeal [published its opinion](#) that our client, Priscila N., who received a domestic violence restraining order in **juvenile dependency court**, could have her restraining order renewed in **family court**. Priscila's case solidified that juvenile dependency courts and family courts throughout California should work together to implement the best protections for survivors of domestic violence. **The victory gave Priscila a second chance at justice** because the appellate court sent the case back to the trial court to hear Priscila's case.

We're thrilled to report that after going back to trial court, Priscila was not only granted a domestic violence restraining order renewal in family court, but it is also permanent. This is the strongest protection available to abuse survivors, and is somewhat rare to obtain. The fact the trial court saw that Priscila needs permanent protection shows how dangerous the original denial of protection was, and the **positive impact appeals can have** both for the safety of Priscila, and also for other survivors across California who may find themselves in situations similar to Priscila's.

FVAP attorneys [Anya Emerson](#), [Jennafer Dorfman Wagner](#), [Shuray S. Ghorishi](#), and [Erin C. Smith](#), were recognized with a [California Lawyer Attorneys of the Year Award](#) for outstanding achievement in family law in March 2018 for their work on Priscila's case, along with our co-counsel, **Manatt, Phelps & Phillips LLP** and **Harriett Buhai Center for Family Law**.

FVAP oral argument being streamed live today

Today, we're in oral argument in Fresno fighting for another survivor's right to fair treatment and custody of her child with co-counsel **Jenner & Block LLP**. The case is about custody and mutual restraining orders, an issue that disproportionately impacts the LGBTQI+ community.

New free trainings on domestic violence restraining orders now available

After collaborating with [Pro Bono Training Institute](#) on a year-long project to include training modules on domestic violence restraining order requests on their website, the modules are now up! [Pro Bono Training Institute](#) was created by Legal Aid Foundation of Los Angeles, OneJustice, and Neighborhood Legal Services of Los Angeles to address the need for attorneys to have free, readily available resources in a central place to use for pro bono work. A year ago, [FVAP](#) recognized that they did not yet have training modules on domestic violence restraining orders. We reached out to see where we could help and were able to collaborate. These training videos are meant to help **pro bono attorneys** as well as **domestic violence advocates** and **survivors** looking for information about the domestic violence restraining order process.

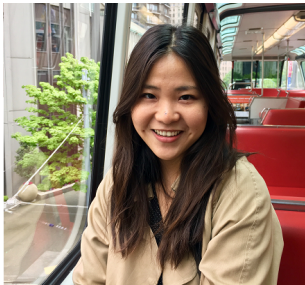

Trial courts must address all 7 rebuttal factors before granting custody to domestic abusers

[FVAP](#) is excited to share with you information about a recently published case, [Jaime G. v. H.L.](#) This published appellate opinion clarifies that before any custody can be granted to a domestic abuser, the trial court must go through each of the **7 factors** in Family Code section 3044 and explain why those factors weigh in favor of granting any custody to an abuser seeking custody. This case will help ensure that trial courts give close attention to the factors that the Legislature has determined are most important to ensure the safety of survivors and children.

Congratulations to **Los Angeles Center for Law and Justice** and their co-counsel **Gibson, Dunn & Crutcher** for this wonderful victory. FVAP has been honored to work with and mentor this powerhouse appellate team for several years, and we're thrilled to see that **building the capacity of**

lawyers in California to appeal domestic violence cases is making a real difference for survivors.
