FVAP's All-staff Meeting on 10/3 with Virtual Backgrounds for Domestic Violence Awareness Month.



Every survivor experiences domestic violence differently, therefore every survivor heals in their own unique way. Listen to the <u>Healing from Domestic Violence podcast</u> where sujatha baliga (sic) shares how she responded to abuse as a child and how restorative justice offers opportunities for survivors to address what they need and want the most–not what society tells them they need.

ADVOCATE TESTIMONIAL

FVAP's positive impact goes far beyond advocacy in family law and restraining order cases.

I used published decisions arising from FVAP's successful litigation in a U visa immigration case for which USCIS sent me a Request for Evidence asking for more evidence that my client had suffered substantial abuse as the underlying reported crime was a violation of a no-contact order and a stay-away order with no physical injury.

In addition to highlighting the unreported history of domestic violence and the stalking pattern, I was also able to show that California statutes as interpreted through case-law took violations of domestic violence restraining orders seriously because such acts are also incidents of domestic violence in and of themselves and they fall within the type of behavior that disturbs the peace as they break the mental and emotional calm of the protected party.

My client's U visa was approved, resulting in her getting legal status, obtaining a 4-year work permit, and putting her on the path to be able to eventually apply for Lawful Permanent Residence. I attached the published decisions arising from FVAP's successful litigation as exhibits.

CHRISTOPHER U. v. PARRIS J. Published October 2023

This case is significant because it affirms that trial courts can include provisions in restraining orders related to financial control such as naming life insurance beneficiaries. Additionally, the higher court recognized a pattern of financial actions that constituted coercive control which underscores the significance of addressing such patterns of behavior as a form of abuse. This ruling serves as an important legal precedent in acknowledging and addressing financial and coercive control within spousal relationships.

FVAP is thankful to have co-counseled this matter with Goodwin Procter, LLP; and to the many domestic violence organizations that filed an amicus (friend of the court) brief in this case to help the court of appeal understand coercive controlling abuse, which includes, Morgan, Lewis & Bockius, Domestic Violence Legal Empowerment and Appeals Project, Stopping Domestic Violence, California Protective Parents Association, Center for

Domestic Peace, Sanctuary for Families, The National Family Violence Law Center at George Washington University Law School, the Law Foundation of Silicon Valley, California Women's Law Center, Community Overcoming Relationship Abuse, Los Angeles Center for Law and Justice, and Women Lawyers Association of Los Angeles.



FVAP is pleased to share that **Zyreena Choudhry**, Staff Attorney in Washington, has been appointed to serve on the **Domestic and Sexual Violence Committee** of the **Gender and Justice Commission**. FVAP is excited to announce that **Evangeline Stratton**, Senior Managing Attorney in Washington has been appointed to serve on the **Crime Services Workgroup** as established by the Washington State Legislature through SB 5187. This work is, similarly led by the **Washington State Supreme Court Gender and Justice Commission**, to convene stakeholders to discuss and recommend to the Legislature evidence-based training needs, standardization and expansion of assistance for crime victims, assessment of funding, and development of a sustainable funding formula.

Both Zyreena and Evangeline will play a vital role in elevating the needs of survivors in the justice system and the work of FVAP.
