THE BOARD OF DIRECTORS AND EXECUTIVE DIRECTOR BOTH INDEPENDENTLY MONITOR AND ENSURE COMPLIANCE WITH THIS POLICY AT MEETINGS OF THE BOARD OF DIRECTORS. IN ADDITION, FVAP'S EMPLOYEE HANDBOOK HAS A CONFLICT OF INTEREST POLICY: "EMPLOYEES AND OFFICIALS MUST NOT PARTICIPATE IN ACTIVITIES INVOLVING THE USE OF GRANT FUNDS WHERE THERE IS A FINANCIAL INTEREST OR BENEFIT (A) TO THEMSELVES, IMMEDIATE FAMILY, PARTNERS, ORGANIZATION (OTHER THAN A PUBLIC AGENCY IN WHICH HE/SHE/THEY IS SERVING AS AN OFFICER, DIRECTOR, TRUSTEE, PARTNER, OR EMPLOYEE); OR (B) TO ANY PERSON OR ORGANIZATION WITH WHOM HE/SHE/THEY IS NEGOTIATING OR HAS ANY ARRANGEMENT CONCERNING PROSPECTIVE EMPLOYMENT.

EMPLOYEES MUST AVOID ACTIONS THAT RESULT IN, OR CREATE THE APPEARANCE OF: (A) USING AN OFFICIAL OR GRANT-FUNDED POSITION FOR PERSONAL GAIN; (B) GIVING PREFERENTIAL TREATMENT TO A PARTICULAR PERSON OR PROJECT; (C) LOSING INDEPENDENCE OR IMPARTIALITY; (D) MAKING A DECISION OUTSIDE OFFICIAL CHANNELS; OR (E) ADVERSELY AFFECTING THE CONFIDENCE OF THE PUBLIC IN THE INTEGRITY OF THE GOVERNMENT OR THE
