The Urgent Problem

Every day, survivors of domestic violence are forced to live under dangerous and unjust court orders that threaten their safety and their children's well-being.

When harm is imminent, standard appeals offer no meaningful relief—**often taking more than 500 days** to resolve. For survivors in crisis, waiting is not an option.

Writs are a rare, high-stakes legal remedy that can intervene quickly. But writs are complex, fast-moving, and historically inaccessible to low-income survivors.

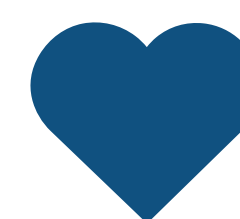
Our Solution

FVAP's **Lifeline to Justice Program** is changing that reality by making emergency writ relief accessible to survivors when it matters most.

Developed through an Equal Justice Works Fellowship and now ready to scale statewide, this program is—to our knowledge—the first and only program in the nation dedicated to providing writ access for domestic violence survivors.
